

1 On November 30, 2015 at approximately 0004 hours, Officer Martin and I responded to the South Turn Bar, located at 1540 S Nova Rd, in
 2 reference to an armed robbery. Upon arrival, I came in contact with the victim, Ryan McKillip, who reported the following: at approximately 2315
 3 hours on November 29, 2015, he had parked his vehicle outside of the South Turn Bar and began to walk in. On his way through the parking lot he
 4 was stopped by an unknown male who was accompanied by an unknown female. The unknown male said "hi" to McKillip. McKillip assumed that
 5 he must know the Unknown male and said "what's up man." The unknown male then told McKillip to come to his car, McKillip replied no and
 6 began to walk away, simultaneously the unknown male stated "I have a gun" and produced a semi-automatic pistol, holding it close to his body but
 7 pointing it at McKillip. McKillip obliged with the unknown males orders and followed him to an older model gold Buick. The unknown male sat in the
 8 front passenger side seat, the female sat in the driver's seat, and McKillip sat in the back seat. While still parked in the parking lot of South Turn
 9 Bar, McKillip told the unknown male that he just wanted to go inside of the bar. McKillip then tried to open the car door but was unable to due to it
 10 being locked.

11 The unknown male and female then drove McKillip across the street to the Citgo Gas Station, located at 1600 S Nova Rd. The unknown male told
 12 McKillip that he needs money so "he can get out of town." The Unknown male said that he would give him a "Baggie" for \$40.00, and produced a
 13 small plastic bag containing a white powdery substance suspected to be cocaine. McKillip stated to the unknown male that he does not want any
 14 drugs. McKillip told the unknown male that he only has \$20.00 on him, and that he would give it to him if he let him go. The unknown male and
 15 McKillip then walked across the street to the TD Bank, located at 1590 S Nova Rd. where the unknown male and McKillip walked up to the ATM.
 16 McKillip once again told the unknown male that he did not want the drugs. The unknown male and McKillip stood in front of the ATM for a short
 17 period of time without ever actually using it. The unknown male finally took the \$20.00 from McKillip and left. McKillip then walked back to South
 18 Turn Bar while texting his brother who called 9-11 for McKillip.
 19 Security footage from South Turn Bar supported McKillip's account of what happened, although a gun is not visible due to the quality and angle of
 20 the video. The video also captures the unknown male inside of the bar moments earlier. The unknown male was allegedly asking bar patrons if
 21 they wanted to buy cocaine, according to the bar manager. The store manager of the Citgo Gas Station stated that neither McKillip nor the
 22 Unknown suspect had been inside of his store to use the ATM.
 23 CID was notified and did not respond to the scene. The store manager of the Citgo Gas Station completed a sworn written statement. Three still
 24 shots of the suspect and 5 video segments were captured and sent into evidence electronically. additional video is available at South Turn Bar if
 25 needed. McKillip can identify the unknown male if he seen again. McKillip wishes to press charges and completed a sworn written statement. This
 26 investigation was captured by Officer Martin's department issued Axon camera.
