

**NARRATIVE CONTINUED**

Officer D. Peralta made contact with him and detained him with no further incident. (See Officer D. Peralta's 707.) The vehicle proceeded east bound on North St. from Clyde Morris. It continued east bound on North St. passing Heineman St. Then it was seen east bound on Hampton Rd. towards White St., then South bound on Colfax St., then east bound towards Nova Rd. The vehicle was driving normal during this time. The vehicle then went through more side streets driving normal at this time. (See CAD report for direction of travel.) Once the vehicle got to Pine Haven, it circled around the apartment complex. Unit were in the area. As the vehicle exited the apartment complex and saw a fully marked police vehicle it picked up speed and began to drive reckless. The defendant blew two of his tires while attempting to elude the police. The vehicle proceeded south on Caroline from Ken St. west on MMB., and north bound Nova Rd. At this point there was a fully marked K9 vehicle with lights and sirens on, the Chief Michael Chitwood was behind the vehicle with his lights and sirens on, and I was behind K9-1. The defendant then proceeded west bound on Dunn Ave. Once at Dunn and Berkshire the Chief was driving next to the defendant. I observed the defendant swerve into the Chief's vehicle side swiping the entire side of his vehicle. This appeared to be an intentional act. The Chief spun out on Dunn Ave. and the defendant left the scene still driving reckless. The defendant proceeded north bound on Berkshire Rd. towards Mason Ave. Once on Mason the defendant drove up on a curb and all over the road not having any concern for other drivers around him. He caused for many cars to slam on their breaks. Once at Mason Ave. and Berkshire Rd. the vehicle came to a stop where the defendant exited and took off on foot from fully uniformed officers and deputies. He was arrested behind 756 Berkshire Rd. and taken into custody. Detective J. Madison read the defendant his Miranda rights and he agreed to speak with him. He advised that he knew the vehicle was stolen, but that the co-defendant (A. Brown) was the one that stole the vehicle. See the interview that was tagged for evidence.



**NARRATIVE CONTINUED**

Officer D. Peralta made contact with him and detained him with no further incident. (See Officer D. Peralta's 707.) The vehicle proceeded east bound on North St. from Clyde Morris. It continued east bound on North St. passing Heineman St. Then it was seen east bound on Hampton Rd. towards White St., then South bound on Colfax St., then east bound towards Nova Rd. The vehicle was driving normal during this time. The vehicle then went through more side streets driving normal at this time. (See CAD report for direction of travel.) Once the vehicle got to Pine Haven, it circled around the apartment complex. Unit were in the area. As the vehicle exited the apartment complex and saw a fully marked police vehicle it picked up speed and began to drive reckless. The vehicle blew two tires while attempting to elude the police. The vehicle proceeded south on Caroline from Ken St. west on MMB., and north bound Nova Rd. At this point there was a fully marked K9 vehicle with lights and sirens on, the chief was behind the vehicle with his lights and sirens on, and I was behind K9-1. The vehicle then proceeded west bound on Dunn Ave. Once at Dunn and Berkshire the Chief (M. Chitwood) was driving next to the defendant. I observed the vehicle swerve into the Chief's vehicle side swiping the entire side of his vehicle. The Chief spun out on Dunn Ave. and the vehicle left the scene still driving reckless. This appeared to be an intentional act. The vehicle proceeded north bound on Berkshire Rd. towards Mason Ave. Once on Mason the defendant drove up on a curb and all over the road not having any concern for other drivers around him. He caused for many cars to slam on their breaks. Once at Mason Ave. and Berkshire Rd. the vehicle came to a stop where the defendant was taken into custody. Detective M. Liles read the defendant his Miranda rights and he agreed to speak with him. He advised that he knew the vehicle was stolen and admitted to taking the vehicle, and then advised that he switched seats with the co-defendant, I. Johnson, who was driving during the chase and who hit the Chief M. Chitwood. See the interview that was tagged for evidence.
