NARRATIVE

1 On May 13, 2016 at approximately 1933 hours, I responded to V-1 business 205 S. Ridgewood Ave. (711) in reference to a burglary. Upon my
 2 arrival I made contact with W-1 store manager (Bharat Patel). W-1 advised today he was checking on his inventory and observed he was missing
 3 approximately \$315.00 of Florida Lotto scratch off tickets. W-1 stated he checked the surveillance footage, and at approximately 0204 hours on
 4 May 13, 2016 he observed S-1 (unknown, black female) and S-2 (unknown, black male) enter the business through the front doors. W-1 advised
 5 S-2 proceeded to the rear of the store to the coolers. W-1 stated S-1 proceeded to the end of the sales counter, where the employees enter behind
 6 the sales counter. W-1 advised he observed on surveillance footage S-1 crouched down to conceal herself behind the sales counter and walked
 7 over to the Florida Lotto ticket dispensers. W-1 stated S-1 stole (7) Florida Cash Lotto scratch off tickets that are \$25.00 each, and (7) Gold Rush
 8 Florida Lotto scratch off tickets that are \$20.00 each. W-1 advised the approximate total of the (14) Florida Lotto scratch off tickets are \$315.00.
 9 S-1 did not have permission to cross the curtilage behind the sales counter, and is not a normal place a person would go to obtain merchandise.

W-1 advised S-2 concealed the bottles of wine into his inside jacket pockets. W-1 advised both bottles of wine are \$8.99 13 each. W-1 also stated he observed S-2 proceed over to the second aisle. W-1 advised on surveillance footage he observed S-2 obtain (1) Solaray 14 Dual USB car charger price of item is approximately \$26.99, and (1) Solaray Charging and Sync Cable price of item is approximately \$19.99. At 15 which point W-1 observed S-2 obtain (1) Lysol Crisp Linen Scent 6 oz. price of item is approximately \$4.39. W-1 stated S-2 was observed 16 concealing all items into his jacket. W-1 advised he observed S-1 and S-2 on surveillance footage walking towards the front doors of the business. 17 W-1 stated S-1 and S-2 both walked passed all points of sales, not intending to purchase the items. W-1 advised approximate value of items that 18 S-2 had stolen was \$69.35. W-1 stated S-2 was observed on surveillance footage leaving the premises on a blue bicycle in an unknown direction. 19 W-1 advised S-1 left the premises on foot in an unknown direction. 20 21 W-1 completed a sworn written statement. W-1 advised he would like to press charges. W-1 provided me with (2) sales receipts for the stolen 22 merchandise. W-1 also provided me with (1) DVD with surveillance footage. W-1 advised he would provide me with a second surveillance footage 23 by email. At this point I have not obtained the additional footage by email. I obtained (3) digital photographs of the stolen items. All evidence was 24 submitted into property and evidence.
