

NARRATIVE The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 04 day of July, 2016, at approximately 0906 a.m. p.m. at 1200 BEVILLE RD #180 DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 On the aforementioned date and time, I responded to the Country Side Apartments located at 1200 Beville Road and apartment #188 in reference to
 2 a home invasion. Prior to my arrival, Officer D. Peralta, Officer A. Walker, and Sgt. C. Hampton were already on scene. Officer Peralta advised me of
 3 the following:
 4
 5 The first victim, Meghan Costello (V-1), stated that she was in the kitchen and Brook Turner's (V-2) brother was located seated on the couch inside
 6 the residence. It should be documented that the first victim is approximately nine months pregnant and was a guest at the residence. The second
 7 victim is the tenant on the lease and lives at the residence. The first victim stated that the second victim's brother stood up from the couch and went
 8 outside for an unknown reason. When her brother left the residence, he did not shut the door properly to where the locking mechanism engages with
 9 the door frame. The door was left open approximately six to eight inches. Noticing that the front door was slightly ajar, the first victim removed herself
 10 from the kitchen and went to close the door. As she was closing the door, the defendant, Robert Dunlop, placed his hand on the door, pushing it
 11 open, and walked inside, uninvited. The first victim stated that the defendant then pointed a silver in color firearm with a brown/wood handle at her

12 head and told her to sit down on the couch. The co-defendant, Jarrerd Hilow, was following the defendant inside the residence. The co-defendant
 13 remained in the living room with the first victim and stated she would not be harmed if she cooperated. The second victim stated she noticed two
 14 distinct "swastika" tattoos on the co-defendant's left and right hands before he put on black gloves to cover his hands. The first victim stated that the
 15 co-defendant was standing with his back facing the front door and noticed that the defendant had walked into the bedroom located in the front of the
 16 residence.

17
 18 Shortly thereafter, the defendant then entered the bedroom located at front of the residence where the second victim and Christopher Aresnault (V-3)
 19 were located. The second and third victim stated that while they were inside the room watching TV, the defendant kicked the door open, causing
 20 damage to the door and forcing himself inside. Both the second and third victim stated the defendant pointed a firearm at them, and heard defendant
 21 yell to the third victim, "Where's my fucking money." The third victim then stated he then dialed 911 and slipped his phone away in his pocket without
 22 the defendant's knowledge. The defendant then held the firearm to the third victim's head and demanded his money. The third victim stated to the
 23 defendant "Bobby, don't make this worse, if you kill me you'll be going to prison for life." The defendant stated to the third victim, "It doesn't matter, I'm
 24 going in nine or eleven days." The third victim then stated to the defendant, "Then shoot me, if you're going to shoot me!" As the defendant was still
 25 holding the gun, and pointing it at the third victim, the third victim began walking towards him, demanding that he leave the house. The third victim
 26 stated as he was walking towards the defendant, the defendant kept walking back to the front door backwards. Both the defendant and the
 27 co-defendant eventually left the residence through the front the door. The third victim stated that is altercation is over bail money for when he was
 28 arrested sometime last week.

29
 30 It should be noted that the second victim stated that she met the defendant sometime last week through mutual friends, and that he works at Gaff's
 31 Meats located in Port Orange. Sometime in the past couple of days, the second victim met with the defendant at the Boot Hill Saloon for some drinks
 32 due to her being actively employed there.

33
 34 All three victims' completed a sworn statement and wished to prosecute against the defendant, and the co-defendant. Crime Scene was notified and
 35 Officer Peralta processed the scene (See Officer Peralta's supplement). Detective Jason Wallace with the Criminal Investigation Division was notified
 36 and arrived on scene shortly thereafter. He then provided me the following information:

37
 38 On Monday, June 4, 2016, at approximately 11:45 PM Detective Jayson Wallace met with the first victim at the Daytona Beach Police Department
 39 located at 129 Valor Blvd. The first victim was shown a photographic line-up containing six photographs, one of which was of the defendant pictured
 40 in photo #5. Upon viewing the photographic line-up, the first victim immediately chose photo #5 as the defendant.

41
 42 Detective Wallace advised the first victim signed and dated the photograph that she chose. The photographic line-up and witness instructions were
 43 submitted into evidence by Detective Wallace. Also submitted into evidence was a copy of the video recording from the interview. Detective Wallace
 44 continued to advised me of the following.

45
 46 On Monday, June 4, 2016, at approximately 11:47 PM Detective Wallace met with the second victim at the Daytona Beach Police Department 129
 47 Valor Blvd. The second victim was shown a photographic line-up containing six photographs, one of which was of the defendant pictured in photo #5.

48 Upon viewing the photographic line-up, the second victim chose photo #5 while stating, "That's him!" The second victim signed and dated the
 49 photograph that she chose. The photographic line-up and witness instructions were submitted into evidence by Detective Wallace. Also submitted
 50 into evidence was copy of the video recording from the interview.
 51
 52 Detective Wallace also advised me that both photo line-ups were viewed separately in different rooms by each individual.
 53
 54 The third victim was able to positively identify the defendant via photo because he is a known individual to him.
 55
 56 At 0204 hours on 07/05/2016, Detective Oakley observed the defendant operating his 2011 White Chevy Malibu bearing FL Tag #ESSN17 within the
 57 1000 Block of S. Atlantic Avenue. After a brief pursuit, the defendant pulled into the 7-11 located at 301 S. Peninsula where a felony stop was
 58 conducted. The co-defendant was detained after he followed Officers orders. The defendant refused to follow orders to exit the vehicle. After the
 59 defendant's refusal, the felony stop then began being treated as a barricaded suspect in a motor vehicle. Officer Goble was able to build a rapport
 60 with the defendant and negotiated his surrender. Sgt. K. Fishpaugh arrived on scene to supervise the negotiation (See Sgt. Fishpaugh's supplement).
 61 At 0301 hours, the defendant surrendered and was taken into custody without incident. Search incident to arrest by Sgt. Goss, yielded the discovery
 62 of a firearm bearing serial # 3043704. The firearm was found loaded, but not chambered and is described as a .25 caliber raven with a pearl handle.
 63 It was later discovered that this firearm was the one used in the armed burglary earlier.
 64
 65 It should be documented that a criminal history was conducted on the defendant and revealed that the defendant is a convicted felon out of Maryland
 66 reference burglary in the first degree. The date for his conviction is on 04/02/2012. It should also be documented that the defendant is on probation
 67 out of Maryland for an armed burglary charge (See Violation of Probation 707).
 68
 69 On 07/05/2016, Detective Oakley conducted a photo line-up where two of the victims were able to positively identify the co-defendant (See Detective
 70 Oakley's supplement). Detective Wallace recovered and tagged the firearm into property and evidence.
