

approximately one week, and Steve Shultz also stated that Glenna Adams had been living with Alfredo Ortiz for a couple of months.

Steve Schultz stated that on the day that he began staying with Alfredo Ortiz and Glenna Adams, 11/09/2001, he saw Alfredo Ortiz walk downstairs from apartment #3 in an effort to find Glenna Adams. Steve Schultz stated that he then heard a noise, like a "pop" and that Glenna Adams walked up the stairs to apartment #3 and that she (Glenna Adams) had "blood dripping out of her hair."

Steve Schultz stated that following that incident he saw Alfredo Ortiz at Willie's Bar and that Alfredo Ortiz told him that he (Alfredo Ortiz) had caught her (Glenna Adams) with Kenny and that he (Ortiz) beat the hell out of Kenny and that he (Ortiz) beat the hell out of her (Adams). Steve Schultz stated that he had heard that Alfredo Ortiz hit Glenna Adams with a coffee table during the 11/09/2001 incident.

Steve Schultz stated that he saw Glenna Adams sleeping in the bedroom she shared with Alfredo Ortiz at approximately 2020 hours on 11/17/2001.

Steve Schultz stated that Alfredo Ortiz came home from the bar at approximately 2100 hours on 11/17/2001, and that Alfredo Ortiz went into the bedroom to sleep at approximately 2115 hours.

Steve Schultz stated that he went to sleep at approximately 2200 hours on 11/17/2001, and that Alfredo Ortiz woke him up about 0400 hours on 11/18/2001, and that Alfredo Ortiz stated that Glenna wouldn't wake up.

Steve Schultz stated that he observed "fresh like blood" on Glenna's hair.

Steve Schultz stated that Alfredo Ortiz then left the apartment to call 9-1-1.

On 11/18/2001, Investigator Tom Frazier (Volusia County Sheriff's Office) and Detective D. Session (Daytona Beach Police Department) interviewed Alfredo Ortiz.

In the interview, Alfredo Ortiz stated that he called 9-1-1 when he "woke up in the morning and seen her (Glenna Adams) right there."

Alfredo Ortiz also stated that "she died because (unintelligible) her own self."

Alfredo Ortiz further stated that "she was a sick person" and that "she died of a bad disease" and that "she only had one year to live."

On 11/19/2001, the Chief Medical Examiner for Volusia County, Dr. Thomas Beaver, performed an autopsy on the victim.

According to the Medical Examiner's Report, Dr. Beaver found blunt force trauma to the head and chest, subdural hematoma (acute and severe), and pulmonary contusions (bilateral, acute, and severe).

Dr. Beaver determined that the cause of death was blunt force trauma to the head and chest and that the manner of death was homicide.

On 11/26/2001, Investigator Frazier (VCSO) interviewed Robin Hefty, who was a friend of Glenna Adams.

In the interview, Robin Hefty stated that Glenna Adams had told him that she was afraid of Alfredo Ortiz and that she was tired of getting beat up.

On 11/08/2001, an affidavit was completed charging Alfredo Ortiz with Battery in reference to an incident in which Glenna Adams was the victim.

In a sworn written statement on 11/08/2001 Glenna Adams wrote that "he (Alfredo Ortiz) just started beating me." Glenna Adams further wrote that "I am in fear of my life. Please don't let him (Alfredo Ortiz) have bond."

It should be noted that on 11/18/2001, Alfredo Ortiz was arrested and charged with Aggravated Battery (Domestic) in reference to the 11/09/2001 incident that Steve Schultz spoke about in which Alfredo Ortiz reportedly hit Glenna Adams with a coffee table.

On 06/26/2004, Alfredo Ortiz was arrested and charged with Felony Battery (Domestic) in reference to an incident involving his girlfriend at the time, Helen McCurnin.

Please see Daytona Beach case number 040602302.

On 08/07/2015, I interviewed Robin Hefty at the Volusia County Branch Jail.

Robin Hefty stated that he was in a relationship with Glenna Adams for approximately one year before her death. Robin Hefty stated that Glenna Adams met Alfredo Ortiz approximately two months after he (Robin Hefty) met Glenna Adams.

Robin Hefty stated that Glenna Adams told him that "He's (Alfredo Ortiz) dangerous" and that "He (Alfredo Ortiz) always beats on me."

Robin Hefty stated that he asked Glenna Adams why she always goes back to him (Alfredo Ortiz) and that Glenna Adams replied that "sometimes he's nice to me."

Robin Hefty stated that after Glenna Adams had died he heard that Alfredo Ortiz was bragging about killing her, so he (Robin Hefty) confronted Alfredo Ortiz.

Robin Hefty stated that Alfredo Ortiz said that he "got away with two murders, a dude and a girl."

It should be noted that Alfredo Ortiz was arrested for Murder in the 2nd Degree on 10/07/1999, but that the State Attorney's filed a No Information in reference to that incident.

The victim in that incident was a male.

Please see Daytona Beach case number 991007049.

Robin Hefty stated that he asked Alfredo Ortiz how he got away with killing Glenna and not go to prison and that Alfredo Ortiz replied "I got it that way."

Robin Hefty stated that these conversations occurred while Alfredo Ortiz was in a relationship with Helen McCurnin. Please refer to the audio recording of the interview for additional information.

On 08/10/2015, I spoke to Helen McCurnin on the telephone.

Helen McCurnin stated that she met Alfredo Ortiz and entered into a relationship with him, and that she dated Alfredo Ortiz on and off for five or six years.

Helen McCurnin stated that on the day that Alfredo Ortiz was arrested, 06/26/2004, he knocked out two of her teeth and he also broke her wrist.

Helen McCurnin stated that during the incident on 06/26/2004 Alfredo Ortiz told her that he was going to kill her like he killed Glenda.

Helen McCurnin further stated that she asked Alfredo Ortiz why he didn't kill her like he killed Glenda and Alfredo Ortiz replied that he loved her (Helen McCurnin) and that he didn't love Glenda.

Steve Schultz stated that when Alfredo Ortiz woke him up at approximately 0400 hours on 11/18/01 Alfredo Ortiz either told him that "I think I killed her" or "I think she's dead."

Steve Schultz further stated that Glenna Adams had fresh blood coming from the cut in her head, and that the cut had been healed when he last saw her on 11/17/01.

Steve Schultz stated that Glenna Adams looked like Alfredo Ortiz had just punched her.

Steve Schultz stated that Glenna Adams and Alfredo Ortiz were alone in the bedroom when Glenna Adams died. Steve Schultz also stated that Glenna Adams and Alfredo Ortiz had been arguing on the night of 11/17/01. Please refer to the audio recording of the interview for additional information.

On 10/13/15, I spoke to Julia Smith (no relation to the victim) on the telephone. Julia Smith stated that she had been friends with Glenna Smith for approximately one year, and that she also knew Alfredo Ortiz.

Julia Smith stated that Alfredo Ortiz was violent when he drank, and that he was "constantly hitting her", referring to the victim, Glenna Smith.

Julia Smith stated that she saw Alfredo Ortiz beat the victim on 11/17/2001, which was the day before the victim was killed.

Julia Smith stated that the victim opened the refrigerator door to get a drink for herself, but that Alfredo Ortiz came running and banged the victim's head against the refrigerator door four or five times.

Julia Smith further stated that Alfredo Ortiz then threw the victim to the ground, and that the victim was bleeding from the head.

Julia Smith also stated that the victim had told her (Julia Smith) that Alfredo Ortiz had told her (the victim) that he had gotten away with murder before, and that he would do it again. Please refer to the audio recording of the interview for additional information.

On 10/22/2015, I spoke to Jeff Herbert on the telephone. Jeff Herbert stated that he observed the victim arrive back at her residence in a taxi cab on 11/17/2001, and that he does not think that the victim's face was covered in blood when she arrived home because he said he would have noticed if the victim was covered in blood.

Please refer to the audio recording of the interview for additional information.

On 10/14/15, Alfredo Ortiz voluntarily responded to the Daytona Beach Police Department for an interview. Alfredo Ortiz stated that he knew the victim, Glenna Smith, for approximately one year before her death. Alfredo Ortiz stated that he and the victim lived together, and slept in the same bed, but that they never had sex with each other.

Alfredo Ortiz further stated that he never hit the victim.

At one point in the interview Alfredo Ortiz stated that the victim died because she was sick, yet later in the interview Alfredo Ortiz stated that the victim died because she had been beat up in a gay bar on Main Street.

Alfredo Ortiz stated that on the night of 11/17/2001 he had been drinking at Willie's Bar, and that when he returned to his residence the victim was already in bed, and that he did not see her face.

Alfredo Ortiz stated that he went to sleep for an unknown amount of time and that when he woke up he realized that the victim was dead.


