Description:

On 09-21-16 at approximately 2130 hours, an unknown white male was observed approaching a young black female juvenile (V-1) in the 200 block of Shady Place. The unknown male (S-1) attempted to solicit the juvenile and after being confronted by V-1's siblings, the suspect intentionally struck V-1 with his vehicle. S-1 then intentionally struck another victim with the vehicle. The vehicle is described as a red 4-door passenger car (unknown make/model). The suspect/driver is described as a white male in his 40's (NOI).

NARRATIVE	1	On September 21, 2016 at approximately 2131 hours I responded to the area of Shady Place and S. Ridgewood Ave. in reference to a hit and run
	2	involving a pedestrian. Upon my arrival I made contact with V2 (Austin Haddock) who was cleaning his injuries in the bathroom of 955 S.
	3	Ridgewood Ave. (7/11 convenience store). V2 advised the following incident had occurred; he and his friend (W1, Dylan Jones) arrived onscene
	4	and parked their vehicle on the south side of the convenience store (7/11) at which point they observed a young female (V1 [REDACTED])
	5	speaking to a white male in his 40's (S1). V2 and W1 approached S1's vehicle which was facing eastbound in a vacant lot located behind the
	6	convenience store. V2 advised that they engaged in verbal altercation with S1 at which point S1 placed his vehicle (red four-door passenger car)
	7	into reverse with the driver door still ajar. V2 advised that he observed S1 driver towards a crowd of people at which point he began to run
	8	northwest from the location. V2 advised that S1 pursued him inevitably hitting him with the front of his vehicle. V2 sustained several lacerations
	9	throughout his body. V2 refused to press charges as well as medical attention. V1 advised that he would be able to positively identify S1.

W1 stated that S1</p> <p>12 placed the vehicle in reverse at which point V1 was hit by the driver side door and drug underneath it. W1 advised that after S1 hit V1 with the</p> <p>13 vehicle he (S1) placed the vehicle in drive, heading westbound on Shady Pl., attempting to hit him (W1) with the vehicle. W1 advised that he was</p> <p>14 able to move out of harm's way; however he did kick the front right headlight causing it to break. W1 advised that S1 then headed northbound on</p> <p>15 S. Ridgewood Ave. from Shady Pl. towards V2. W1 advised that he did not observe S1 hit V2 with the vehicle. W1 completed a sworn witness</p> <p>16 statement. W1 advised that he would be able to positively identify the driver.</p> <p>17</p> <p>18 V1 advised the following incident had occurred; on 09/21/2016 at approximately 1500 hours she was walking home from the school bus stop when</p> <p>19 S1 approached her in his vehicle. V1 advised that S1 stated the following; "Wanna get in my car and go around the corner?" V1 advised that she</p> <p>20 said "No" at which point S1 drove off and she continued to walk home. V1 advised that at approximately 2100 hours she was walking northbound</p> <p>21 across Shady Pl. towards the 7/11 when she observed S1's vehicle parked in a vacant parking lot east of the 7/11. V1 advised that when she</p> <p>22 walked behind S1's vehicle to walk towards the 7/11 when S1 opened his driver side door and peaked his head out of the vehicle in effort to speak</p> <p>23 to V1. V1 stated that S1 stated the following; "Suck my Dick and I'll give you money" V1 advised that she alerted her brothers and sisters at which</p> <p>24 point S1 reversed his vehicle and hit V1 with the driver door. V1 stated that she was drug underneath the driver door. V1 advised that she does</p> <p>25 want to press charges. V1 sustained minor lacerations; however, she was transported to Halifax Hospital for further medical evaluation. V1</p> <p>26 advised that she has never seen S1 prior to today and has never spoken to him prior to this incident.
