5 Officer J Jackson was advised that (V-1) was diagnosed with Asperger's. Officer J Jackson contacted V-1 a block away from			
6 home on Pierce St. V-1 was crying and extremely emotional. V-1 stated that ran away from home today because was about to get "a beating".			
7 V-1 stated that the reason was about to be disciplined is due to recent behavior at school today (9/24/16). V-1 stated that teacher made			
8 angry and kicked him. V-1 stated that parents also abuse giving more of a reason to flee the residence. V-1 stated that prior to leaving			
9 the residence was hit by mother with a two foot paddle board that had holes drilled through it. V-1 showed Officer M. Lee and Officer J Jackson			
10 a red fresh looking welt located on ankle that was approximately 2x2 inches wide. V-1 also stated that had bruising on buttocks from a			
11 couple of days ago. V-1 stated was very afraid and no longer wanted to be at the above listed address. This being the reason why V-1 left the

12 above listed address. V-1 was calmed down and transported back to [redacted] house.

13 When we arrived at the house, Officer J Jackson was contacted by (Def-2) Carlina Boykin and (Def-1) Matthew Neely. Def-2 is the mother of V-1 and

14 Def-1 and Def-2 are currently in a romantic relationship and currently reside at [redacted] as a family unit. Def-2 was advised of the allegations

15 of abuse. Officer J Jackson asked Def-2 to bring the paddle from inside the house so we could see it.

16 The paddle was as described above. The paddle was transferred over into our possession. Def-2 stated that the paddle was made as a device to

17 scare V-1 in an attempt to make [redacted] behave in school. Def-2 stated that this has been an ongoing issue. Def-2 stated V-1 gets upset when things do

18 not go [redacted] way. Def-2 stated that V-1 was disciplined for not behaving in school. Def-2 stated that V-1's toys and games were removed from [redacted] room

19 prior to [redacted] arrival from school. Def-2 stated that V-1 became extremely upset and left the house after realizing [redacted] items were removed from [redacted]

20 room. Def-2 stated that V-1 has been admitted into (HBS) Halifax Behavioral Services once before. Def-2 stated she is scared of V-1 when [redacted]

21 becomes angry, she refuses to be home alone with V-1. Def-2 stated that she's never used the paddle on V-1 before.

22

23 Def-1 admitted to using the paddle on V-1 on Tuesday (9/27/2016). Def-1 stated he had physically disciplined V-1 three times and each time was for

24 misbehavior. Def-1 stated that he made the paddle himself on Sunday (9/25/2016). As stated by Def-2, Def-1 stated it was made in order to put fear

25 in V-1 to make [redacted] behave better in class. Def-2 also stated that V1 needed something to scare [redacted] because when they spanked V1 in the past with

26 a belt or a paddle with no holes that V1 would just laugh at them.

27

28 Sgt. Ousterman arrived on scene and notified (CID) Criminal Investigations Division of the incident.

29

30 Officer Boone Transported V-1 to the hospital for further evaluation of physical injuries. He also took photos of V1 and forwarded them to Detective

31 Massengale.

32

33 (DCF) Department of Children and Families was called and notified of this incident. DCF worker Steve, number 2064 stated that a report would be

34 taken.

35 This investigation was captured on Officer's M. Lee AXON camera.

36

37 Officer T. Houssamy stood by with Def-1 and Def-2 and took custody of the paddle to tag into evidence at Valor.

38 Officer Boone made contact with Dr. Mary Vanino at Halifax Medical Center. Dr. Vanino examined the victim. Dr. Vanino stated that the bruising on

39 the child's buttocks and ankle are deep and consistent with child abuse. Dr. Vanino advised that the bruising may have been sustained as early as

40 Tuesday, September 27, 2016. The defendant disclosed to Officer J Jackson and Officer M Lee who were on scene that he struck the victim's

41 buttocks with the paddle on Tuesday, September 27, 2016. Pictures of the victim's injuries were taken at the hospital and submitted as evidence by

42 Detective Massengale. Officer Boone advised that V-1 stated that [redacted] was hit with a wooden paddle with multiple holes in them. V-1 advised that [redacted]

43 was hit on [redacted] buttocks on Tuesday, September 27, 2016 and again on Thursday September 29, 2016 after [redacted] misbehaved in class. V-1 suffered from

44 a reddish colored mark on [redacted] right ankle. (See Officer Boone's supplement for more details)

45 Officer Houssamy made contact with Def-1 and took him into custody. After transporting Def-1 to the precinct, Def-1 asked Officer Houssamy on the

46 health of V-1. Officer Houssamy responded that V-1 will be okay with the proper help. Def-1 asked how serious the crime was since he has never

47 been in any serious trouble. Officer Houssamy responded by stating that there is a difference between disciplining a child and abusing a child and

48 when the doctor advises that the injuries are consistent with child abuse then it becomes a charge. Def-1 spontaneously uttered to Officer Houssamy
49 that on Monday September 26, 2016 he picked up a wooden paddle and beat V-1 five times and on the sixth time he observed V-1 jump as if [redacted] was
50 in pain. Def-1 advised that the reason he was disciplining V-1 is because [redacted] got a phone call from [redacted] school advising that V-1 was bullying other kids.
51 Def-1 advised that when he realized that the paddle worked, he customized it and placed holes in it in order to make it look scary and motivate V-1 to
52 behave. Def-1 advised that prior to the paddle, V-1 would laugh at Def-1 while disciplining [redacted] with a belt and that's the reason he made this paddle.
53 Def-1 advised that he was disciplined by his father when he was a child the same way and it worked for him.
54 Def-1 was read Miranda and sworn by Detective Draugelat. Def-1 admitted to Det Draugelat that on Monday September 26, 2016 he made a wooden
55 paddle and struck V-1 approximately six times in the buttocks due to V-1 misbehaving in school.. (For more details see taped interview).
56 Def-2 was read Miranda and sworn by Detective Draugelat. Def-2 stated that she observed Def-1 hit V-1 approximately 10 times in the buttocks with
57 a wooden paddle. Def-2 advised that after Monday September 26, 2016. Both she and Def-1 did not strike V-1. (For more Details see taped
58 interview)
59 V-1 stated to Dr. Vanino and Officer Boone that Both Def-1 and Def-2 have struck him, V-1 advised that Def-2 struck [redacted] with the paddle on [redacted] right
60 ankle for misbehaving in school.
61 Def-2 was taken into custody.
62 Rita Moore (DCF Agent) took custody of V-1 and interviewed both Def-1 and Def-2.
63 Both Def-1 and Def-2 committed the act of aggravated child abuse by striking the child with a weapon (Wooden Paddel).
64 This incident was recorded on Officer Houssamy's Axon camera#6411



6 home on Pierce St. V-1 was crying and extremely emotional. V-1 stated that ran away from home today because was about to get "a beating".			
7 V-1 stated that the reason was about to be disciplined is due to recent behavior at school today (9/24/16). V-1 stated that teacher made			
8 angry and kicked him. V-1 stated that parents also abuse giving more of a reason to flee the residence. V-1 stated that prior to leaving			
9 the residence was hit by mother with a two foot paddle board that had holes drilled through it. V-1 showed Officer M. Lee and Officer J Jackson			
10 a red fresh looking welt located on ankle that was approximately 2x2 inches wide. V-1 also stated that had bruising on buttocks from a			
11 couple of days ago. V-1 stated was very afraid and no longer wanted to be at the above listed address. This being the reason why V-1 left the			
12 above listed address. V-1 was calmed down and transported back to house.			
13 When we arrived at the house, Officer J Jackson was contacted by (Def-2) Carlina Boykin and (Def-1) Matthew Neely. Def-2 is the mother of V-1 and			
14 Def-1 and Def-2 are currently in a romantic relationship and currently reside at as a family unit. Def-2 was advised of the allegations			
15 of abuse. Officer J Jackson asked Def-2 to bring the paddle from inside the house so we could see it.

16 The paddle was as described above. The paddle was transferred over into our possession. Def-2 stated that the paddle was made as a device to
17 scare V-1 in an attempt to make [redacted] behave in school. Def-2 stated that this has been an ongoing issue. Def-2 stated V-1 gets upset when things do
18 not go his way. Def-2 stated that V-1 was disciplined for not behaving in school. Def-2 stated that V-1's toys and games were removed from [redacted] room
19 prior to [redacted] arrival from school. Def-2 stated that V-1 became extremely upset and left the house after realizing [redacted] items were removed from [redacted]
20 room. Def-2 stated that V-1 has been admitted into (HBS) Halifax Behavioral Services once before. Def-2 stated she is scared of V-1 when [redacted]
21 becomes angry, she refuses to be home alone with V-1. Def-2 stated that she's never used the paddle on V-1 before.
22
23 Def-1 admitted to using the paddle on V-1 on Tuesday (9/27/2016). Def-1 stated he had physically disciplined V-1 three times and each time was for
24 misbehavior. Def-1 stated that he made the paddle himself on Sunday (9/25/2016). As stated by Def-2, Def-1 stated it was made in order to put fear
25 in V-1 to make [redacted] behave better in class. Def-2 also stated that V1 needed something to scare [redacted] because when they spanked V1 in the past with
26 a belt or a paddle with no holes that V1 would just laugh at them.
27
28 Sgt. Ousterman arrived on scene and notified (CID) Criminal Investigations Division of the incident.
29
30 Officer Boone Transported V-1 to the hospital for further evaluation of physical injuries. He also took photos of V1 and forwarded them to Detective
31 Massengale.
32
33 (DCF) Department of Children and Families was called and notified of this incident. DCF worker Steve, number 2064 stated that a report would be
34 taken.
35 This investigation was captured on Officer's M. Lee AXON camera.
36
37 Officer T. Houssamy stood by with Def-1 and Def-2 and took custody of the paddle to tag into evidence at Valor.
38 Officer Boone made contact with Dr. Mary Vanino at Halifax Medical Center. Dr. Vanino examined the victim. Dr. Vanino stated that the bruising on
39 the child's buttocks and ankle are deep and consistent with child abuse. Dr. Vanino advised that the bruising may have been sustained as early as
40 Tuesday, September 27, 2016. The defendant disclosed to Officer J Jackson and Officer M Lee who were on scene that he struck the victim's
41 buttocks with the paddle on Tuesday, September 27, 2016. Pictures of the victim's injuries were taken at the hospital and submitted as evidence by
42 Detective Massengale. Officer Boone advised that V-1 stated that [redacted] was hit with a wooden paddle with multiple holes in them. V-1 advised that [redacted]
43 was hit on his buttocks on Tuesday, September 27, 2016 and again on Thursday September 29, 2016 after [redacted] misbehaved in class. V-1 suffered from
44 a reddish colored mark on [redacted] right ankle. (See Officer Boone's supplement for more details)
45 Officer Houssamy made contact with Def-1 and took him into custody. After transporting Def-1 to the precinct, Def-1 asked Officer Houssamy on the
46 health of V-1. Officer Houssamy responded that V-1 will be okay with the proper help. Def-1 asked how serious the crime was since he has never
47 been in any serious trouble. Officer Houssamy responded by stating that there is a difference between disciplining a child and abusing a child and
48 when the doctor advises that the injuries are consistent with child abuse then it becomes a charge. Def-1 spontaneously uttered to Officer Houssamy
49 that on Monday September 26, 2016 he picked up a wooden paddle and beat V-1 five times and on the sixth time he observed V-1 jump as if [redacted] was
50 in pain. Def-1 advised that the reason he was disciplining V-1 is because he got a phone call from his school advising that V-1 was bullying other kids.
51 Def-1 advised that when he realized that the paddle worked, he customized it and placed holes in it in order to make it look scary and motivate V-1 to
52 behave. Def-1 advised that prior to the paddle, V-1 would laugh at Def-1 while disciplining him with a belt and that's the reason he made this paddle.
53 Def-1 advised that he was disciplined by his father when he was a child the same way and it worked for him.
54 Def-1 was read Miranda and sworn by Detective Draugelat. Def-1 admitted to Det Draugelat that on Monday September 26, 2016 he made a wooden
55 paddle and struck V-1 approximately six times in the buttocks due to V-1 misbehaving in school.. (For more details see taped interview).
56 Def-2 was read Miranda and sworn by Detective Draugelat. Def-2 stated that she observed Def-1 hit V-1 approximately 10 times in the buttocks with
57 a wooden paddle. Def-2 advised that after Monday September 26, 2016. Both she and Def-1 did not strike V-1. (For more Details see taped
58 interview)
59 V-1 stated to Dr. Vanino and Officer Boone that Both Def-1 and Def-2 have struck him, V-1 advised that Def-2 struck [redacted] with the paddle on [redacted] right
60 ankle for misbehaving in school.
61 Def-2 was taken into custody.
62 Rita Moore (DCF Agent) took custody of V-1 and interviewed both Def-1 and Def-2.
63 Both Def-1 and Def-2 committed the act of aggravated child abuse by striking the child with a weapon (Wooden Paddel).
