

#### Description:

The heavy set white male depicted in the photograph is one of three males that was possibly involved in the detainment of a young white female within the trunk of a vehicle. This incident took place on 10/10/2016 between 0827 and 0847 hours. This BOLO contains an actual photo of the vehicle stationary in the parking lot of the incident location (2675 W. US 92). Due to the degraded video quality, a photograph of a vehicle similar to the actual involved vehicle is also attached. The vehicle is identified as a 2014 Hyundai Elantra with an assigned Ohio license plate # GHS5943. If the male(s) in question is identified and contacted, conduct a field interview, complete a supplemental report and take any other actions that are deemed necessary.

**NARRATIVE**

1 I responded to 2675 West US 92 (Speedway Gas Station) in reference to a suspicious incident investigation. When I arrived, I contacted two reporting persons identified as [REDACTED] (Speedway gas station employee) and [REDACTED] (Speedway gas station customer) and was told that the following incident transpired:

4 A gray-colored 2014 Hyundai Elantra vehicle occupied by 3 white males, was driven to gas pump # 8, which was located in the Speedway gas station parking lot. All 3 of the white males exited the vehicle and loitered near the vehicle between 0827 and 0847 hours (October 10th, 2016). During that time, one of the unidentified white males (S1) walked into the gas station and made a cash purchase at 0836 hours (according to the video surveillance time stamp). After making the purchase, S1 returned to the vehicle.

8 According to [REDACTED] he observed S1 open the trunk of the Hyundai Elantra vehicle for a brief moment. While the trunk of the vehicle was opened, [REDACTED] caught a glimpse of what appeared to be an alive young white female(O1) partially covered in a blanket. [REDACTED] described the white female as only as having "reddish-brown" hair. [REDACTED] stated that before he could determine the status of the female (whether or not

11 she was in distress), S1 told the female to "watch your head down" prior to quickly closing the trunk. After closing the trunk, S1 and the remaining  
 12 two unidentified white males entered the vehicle and took flight west bound on West US 92 towards interstate 95.  
 13 After observing this incident, [REDACTED] went into the store and relayed this suspicious incident (along with the vehicles Ohio License Plate number )  
 14 to [REDACTED]  
 15 [REDACTED] completed sworn written statements.  
 16 During my investigation, Rita Devine (Area store manager) provided me with a copy of the video surveillance footage of S1 entering and leaving  
 17 the store along with surveillance of the Hyundai vehicle being stationary at pump #8 for approximately 20 minutes. The clarity of the exterior video  
 18 surveillance was sub par. However, I was able to capture a still shot photo of S1.  
 19 A copy of the video surveillance and the still shot photo was submitted to the DBPD property and evidence division. A BOLO for the vehicle and  
 20 S1 was disseminated via departmental e-mail and to surrounding law enforcement agencies.  
 21 Assisting patrol officers attempted to locate the Hyundai vehicle with no success.
