**NARRATIVE** The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 18 day of October, 2016, at approximately 0311 a.m. p.m. at DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 The defendant and the victim, have two children in common, and . is currently  
 2 seven months pregnant with the defendant's child, which the defendant has knowledge of. The defendant and do not currently reside together.

 4 On Tuesday, October 18, 2016, at approximately 0257 hours, multiple units responded to in reference to a Domestic  
 5 Disturbance. Once on scene, I made contact with and , while other units made contact with the defendant. The  
 6 following was discovered:

 8 who was visibly shaken and emotionally distraught advised she was sleeping in her residence, located at the above location, when she  
 9 was woken up by the sound of glass being broken stated she heard someone enter the residence and then observed the defendant with a  
 10 hammer inside of her bedroom stated the defendant struck her multiple times with the hammer, then he left the room, entered the room  
 11 was in, and started striking her with the hammer advised she fled the apartment in fear for her life. stated moments later the  
 12 defendant started running after her and pushed her to the ground on the west side of 429 Jean St. advised the defendant then ripped off her  
 13 boxers and underwear while continuing to strike her with his hands. stated the defendant then pushed her legs towards her stomach and put  
 14 forcefully put his penis and fist inside of her, vaginally, without her consent. advised she attempted to get away from the defendant but was  
 15 unsuccessful do to the defendant holding her down and preventing her from leaving. stated came and removed the defendant off of

16 her at which time officers arrived on scene.

18 [redacted] advised she was also sleeping inside of the above location when she was woken up to glass being broken. [redacted] advised she observed

19 the defendant walking through the apartment with a hammer in his hand. [redacted] stated the defendant started to strike [redacted] with the hammer.

20 [redacted] advised the defendant then kicked in her bedroom door with hammer in hand and started to strike her with the hammer. [redacted] stated the

21 defendant dropped the hammer and began striking her with his hands and feet in her face. [redacted] advised [redacted] ran out of the apartment and the

22 defendant followed right behind her. [redacted] stated she then got her phone and contacted the police. [redacted] advised she exited the residence and

23 discovered the defendant on top of [redacted] continuously striking her [redacted] she ran over to [redacted] and the defendant and attempted to prevent the

24 defendant from causing any further harm to [redacted]. [redacted] made the statement that the defendant sexually battered [redacted], but at no point did she

25 observe the defendant's hand or penis inside of [redacted] vagina. [redacted] stated the police showed up a short time later and she was able to remove

26 [redacted] from the defendant.

27

28 [redacted] neighbor, [redacted], just returned from the convenience store and observed the defendant sitting on the outside porch of the [redacted]

29 apartment. [redacted] advised the defendant looked at her, put his finger over his mouth, and said "shhhhhhh". [redacted] stated the defendant then yelled

30 "Fuck it", got up from the chair, and started to hit the window next to the front door with a hammer. [redacted] advised the defendant then reached inside

31 of the window and unlocked the door. [redacted] stated she immediately contacted the police as the defendant entered [redacted] apartment with the

32 hammer. [redacted] stated she then heard [redacted] screaming from within the apartment. [redacted] advised the screaming then stopped and [redacted] ran out of

33 the front door of her apartment and south on Jean St. [redacted] stated the defendant followed her from the residence and took [redacted] to the ground by

34 pulling her hair. [redacted] stated [redacted] then ran out of the residence. [redacted] stated the defendant started to rip off [redacted] clothing in the grass and

35 started to grope her. [redacted] advised [redacted] and multiple neighbors get the defendant off of [redacted] and officers then arrive on scene. [redacted] advised

36 she does not know [redacted], or the defendant and that [redacted] recently moved into the apartment complex.

37

38 Another one of [redacted] Neighbor, [redacted] who resides at [redacted] was sitting on her outside porch. [redacted] stated she

39 heard a window break. [redacted] advised she observed the defendant then enter [redacted] residence through the front door. [redacted] stated she then

40 started to hear [redacted] screaming from within the apartment. [redacted] advised [redacted] then ran out of the apartment, where the defendant chased her

41 and caught her behind a building. [redacted] stated the defendant continued to beat [redacted] and [redacted] was trying to prevent him from doing so.

43 After law enforcement arrival, the defendant was laying on the ground with his right hand in his pocket. The defendant refused to comply with

44 commands given by the officers. The defendant had his hand in his pocket, which he refused to remove. The defendant is known to be armed with a

45 firearm by [redacted] but one was never seen or implied on during the above incident. The defendant eventually submitted and removed his

46 hand from his pocket and was taken into custody.

47

48 [redacted] completed a written statement and [redacted] advised she wants to press charges for the above incident. [redacted] was

49 unable to complete a written statement, therefore [redacted] complete a sworn statement on my Axon Body Camera (ID#8722). [redacted] also advised she

50 wanted to press charges. [redacted] had a minor laceration to the rear of her head refused any medical treatment at the time of this report. [redacted] was

51 placed into the rear of my patrol vehicle and transport to the intersection of Jean St and Orange Av due to Volusia County EVAC refusing to come on

52 scene due to their being an active threat to them. [redacted] was transported to Halifax Medical Center via EVAC to be treated for possible injuries to her

53 unborn child. Once at the hospital, [redacted] refused to have the SANE nurse respond, but later changed her mind and the SANE nurse, Sandra

54 Blanding, was contacted.

55

56 A crime scene was established behind 429 Jean St, where [redacted] clothing articles were located, and inside of [redacted] 1. Crime

57 Scene Investigator C. Lampe arrived on scene and processed both scenes (See Crime Scene Investigator C. Lampe's supplemental report for more

58 information).

59

60 The defendant was discovered to have an open Volusia County warrant (see additional arresting affidavit for more information).

61

62 The defendant was transferred to prisoner transport and later transported out to the Volusia County Branch Jail.


