NARRATIVE The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 15 day of November, 2016, at approximately 1120 a.m. p.m. at 305 Fentress Blvd DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 On November 10, 2016 at 0700 hours [REDACTED], executed a search
 2 warrant at 160 Acklins Circle, Unit 308 Daytona Beach, FL. This search warrant was issued on November 04, 2016 and signed by Judge
 3 Foxman. This search warrant was in reference to an ongoing child exploitation case of an unknown occupant utilizing a file sharing network to
 4 download and distribute child pornography.
 5 On November 10, 2016, [REDACTED], wearing plain clothes with our badge identification displayed, knocked on the door of the above
 6 address and waited for the defendant to answer the door. Once the defendant answered the door I asked him if he would mind talking to us, to which
 7 he agreed. I advised the defendant that I appreciated him taking the time to speak with us, even though he did not have to and that we were sorry for
 8 bothering him so early.
 9 We explained to the defendant that we were there to investigate a complaint of child exploitation. I asked the defendant if any kids lived in the house
 10 and he stated "no" The Defendant was asked if anyone else lived or stayed in his apartment and he stated that he is and has been then only person
 11 that lives there. I asked the defendant if he had any computers and he stated that he did, and that they were password protected and that he was the
 12 only one that uses them. [REDACTED]

 15 The Defendant was asked if he was familiar and uses [REDACTED] peer-to-peer network and he stated that he has, and does use it [REDACTED]

1 [REDACTED]. The defendant stated that he is very familiar with how [REDACTED] works, even to the point of understanding that when he
2 downloads files, [REDACTED]. The defendant was asked if he ever downloaded child pornography using [REDACTED]
3 Initially the defendant stated the he does not download child porn on purpose, but that he has by accident. I asked the defendant what terms he uses
4 that find child porn on [REDACTED] and he stated "LS". "LS" is the name for a known series of child pornographic images, including ones that I had
5 observed the defendant with during the initial phase of this investigation.
6 The defendant then changed his story and stated that he does indeed like to download images and videos on underage children and that he usually
7 either deletes them, or places leaves them in his [REDACTED] folder. The defendant stated that he has been downloading child pornography for a few
8 years and that he should have approximately 500 images on his desktop computer in his apartment. The defendant stated that he also uses a tool
9 called [REDACTED] " to permanently delete these images once he is done with them. The defendant then invited us in to his house to show us his
10 "child pornography" at which point I advised the explained to the defendant that I had a search warrant for the apartment and that I would now be
11 executing this search warrant
12 I read the defendant the search warrant and his rights according to Miranda and he stated that he understood his rights and would speak with me.
13 I asked the defendant what software he uses to download child pornography, and the stated that he used both [REDACTED] and the internet. The
14 defendant stated that he has downloaded the "LS" series of child pornography and that the age ranges of those nude children were (8-10) years old.
15 The defendant stated that he likes to download the images, then masturbate to them, but that he would never consider touching a real child. The
16 defendant stated that he did not understand what the big deal was, because he was not the person in the pictures that were sexually battering the
17 children, I explained to the defendant the concept of supply and demand, and that without the demand for these images, there would be no supply
18 and that he was a part of this demand by downloading them.
19 I asked the defendant if anyone else lived or stayed with him and he again stated that he lives alone and is always the only one in the house.
20 I showed the defendant a series of child pornographic images that I had downloaded from him and asked him if he recognized them. The defendant
21 stated that all of the images I showed him, were ones that he had downloaded recently. The defendant stated that he downloads those images, then
22 deletes them because he feels disgusted, then downloads them again at a later date. He stated that he down not know why he continues to
23 download them but can't help himself. The defendant reiterated the previous conversation we had at the front door about "LS" and the amount of
24 images he should have on his computer. The defendant then provided me the password for his computer "lizybaby22"
25 The defendant completed a sworn statement about his involvement in downloading child pornography, apologizing for his action.
26 I began to search the apartment and seized, in part, the following item:
27 HP Desktop Serial# G5T4H02
28 The above item was tagged into DBPD evidence for processing and a copy of the search warrant and inventory was left in the residence with Chad
29 Bowen.
30 On 11/10/2016 pursuant to the lawful execution of a search warrant, an HP Desktop Computer model # Inspiron 3647, Serial # G5T4H02 was seized.
31 In reference to the above computer, I received the computer, opened the case and removed the internal hard disk drive.
32 On November 10th, 2016 at 2:03pm, a check of the bios software for the above computer disclosed the date and time as November 10th, 2016
33 2:04pm.
34 On November 10, 2016 I created a forensic image of this hard drive utilizing a Tableau write blocking device and AccessData Forensics Tool Kit
35 Imager, version 3.4.2.2.
36
37 Between November 10, 2016 and November 11, 2016, I conducted a forensic examination of this hard drive using a Tableau write blocker and a
38 licensed copy of Forensic Tool Kit, ver.6.1. Upon examining the hard drive I noted the following facts which may be of evidentiary value.
39 It was determined that the hard drive had a total capacity of 465.8 GB, including 275GB which are listed as unallocated. This hard drive has seven
40 partitions:
41 Partition one did not contain an operating system and was identified as a EFI System partition only.
42
43 Partition two did not contain an operating system and was identified as a Basic data partition only.
44 Partition three did not contain an operating system and was identified as a Microsoft Reserved partition only.
45
46 Partition four did not contain an operating system and was identified as a Basic data partition only.
47 Partition five contained an NTFS files system and had an installed operating system of Microsoft Windows 10 Home with a product ID of
48 00326-10000-00000-AA792. This operating system was installed on September 23, 2016.
49 Partition six did not contain an operating system and was identified as a Basic data partition only.



1 Partition seven did not contain an operating system and was identified as a Microsoft recovery partition only.
2 I located the SAM file (Security Accounts Manager) and discovered that there were three system generated default user profiles and one user
3 generated profiles. System generated profile "Administrator" had a SID (Security Identifier) of 500. System generated profile "Guest" had a SID
4 (Security Identifier) of 501.
5 System generated profile "Default Account" had a SID (Security Identifier) of 503.
6 User generated profile "Chad Bowen" had a SID (Security Identifier) of 1001. This account indicated that a password is required to logon to this
7 profile.
8
9 Further Analysis of the files under the "Chad Bowen" (SID 1001) profile revealed numerous files identifying Chad Bowen as the user of the above
10 computer, to include numerous images of Chad Bowen and his pets. I also located artifacts of an email address of Chad.Bowen5@gmail.com
11 I located under the "Chad Bowen" (SID 1001) profile, approximately 25,000 images that were of notable content (suspected child pornography), (20)
12 of these files were selected for inclusion into an affidavit and are listed by description further in this report. These files were located under the "Chad
13 Bowen" (SID 1001) profile, in the UserschadDownloads directory, as well as the UserschadAppData directory.
14 I located excel type spreadsheets which contained numerous embedded images of child pornography.
15 I located installed [REDACTED] software, version 7.9.7, and known child pornography [REDACTED] files, consistent with the one(s) that were recorded in the
16 initial phase of this investigation.
17 I located anti-forensics software "[REDACTED]", commonly used to permanently delete files.
18 I located Active antivirus and anti-malware software.
19 I located internet history, file history and search history, all which are associated with child pornography, such as:






