Update

On 12/06/2016, at approximately 0600 hours, the United States Marshal New York/New Jersey Fugitive Task Force apprehended Andre Lenard Mayo in Brooklyn, New York on two 1st degree murder warrants. Mayo was wanted by the Daytona Beach Police for the murders of Stanley and Morel. Mayo was taken into custody based on an on-going year investigations by the United States Marshall Service- Florida/Caribbean Regional Fugitive Task Force, Volusia County Sheriff's Office and the Daytona Beach Police Department. Mayo attempted to evade apprehension during the incident, but was found hiding in a closet under clothing. Mayo will be extradited back to Florida to face charges, Dawson already in custody.

16 Video surveillance shows that one of the shooters is a male wearing a black leather jacket, white t-shirt, and shorts.

17 Video surveillance then shows that the shooter with the black leather jacket hides behind a black SUV on the east side of Pearl Street and continues

18 to shoot towards a group of white males who are hiding behind a green Chevrolet Impala.

19 It should be noted that the video surveillance shows one of the white males hiding behind the Chevrolet Impala and returning gunshots toward the

20 shooter in the black leather jacket.

21 Several people then scatter and leave the scene on foot and in several different types of vehicles.

22 Several people then enter the Chevrolet Impala with the victim, Abel Morel, in the passenger's front seat. The vehicle then proceeds into motion,

23 driving south on Pearl Street, and a short distance later the victim, Morel, falls out of the vehicle. The driver of the vehicle, later identified as Abriauna

24 White, returned to the location where Abel Morel had fallen out of the vehicle, Dr. Mary McLeod Bethune Blvd. and Pearl Street.

25 The other people who entered the victim's Chevrolet Impala were Joseph Dudley and Tyler Montgomery.

26 The occupants of the victim's Chevrolet Impala found the victim, Abel Morel, at the intersection of Dr. Mary McLeod Bethune Blvd. and Pearl Street.

27 Victim Abel Morel was transported to Halifax Hospital by EVAC, where he was pronounced dead.

28 Video surveillance shows that the shooter wearing the black leather jacket fired a gunshot towards the Chevrolet Impala as the Impala was leaving

29 the scene southbound on Pearl Street.

30 Det. Dinardi interviewed Joseph Dudley at 129 Valor Blvd.

31 Joseph Dudley stated that Kevin Stanley got into a fight with a black male in the 300 block of Pearl Street, and then a black male started shooting.

32 Joseph Dudley stated that he did not get a good look at the shooter, but that he was wearing a black hooded sweatshirt.

33 Joseph Dudley stated that he did not know that Abel Morel had a gun, but that after the black male suspect began shooting at them Abel Morel pulled

34 out a gun and fired towards the black male suspect, in defense of himself and his friends.

35 Det. Nathaniel Williams interviewed Tyler Montgomery at 129 Valor Blvd.

36 Tyler Montgomery stated that Kevin Stanley got into a fight with a black male, and that following the fight a crowd began to form around them.

37 Tyler Montgomery stated that he then heard gunshots, but he did not see the shooter.

38 Tyler Montgomery and Joseph Dudley gave sworn verbal statements that were audio and video recorded.

39 The suspect shooter wearing the black leather jacket has been identified as Andre Mayo, and Andre Mayo currently has a warrant for 1st Degree

40 homicide in reference to this incident.

41 Based on ballistic evidence recovered at the scene, it appeared that there were two people shooting during the incident, in addition to Abel Morel

42 returning gun shots from his handgun.

43 There were four shell casings recovered that appeared to have been fired from a .380 handgun, and six shell casings that appeared to have been

44 fired from a .40 caliber handgun.

45 There were also approximately five shell casings that appeared to have been fired from a 9mm handgun. The 9mm shell casings were recovered on

46 the sidewalk on the west side of Pearl Street, behind where Abel Morel's Chevrolet Impala was parked.

47 It should be noted that Joseph Dudley showed Detective Dinardi where Abel Morel's handgun was, and Abel Morel's gun was a 9mm.

48 Based on the surveillance video, it appears that the male in the black leather jacket, identified as Andre Mayo, was shooting the .380 handgun, and

49 that the second shooter was firing the .40 caliber handgun.

50 On 01/09/16, a cooperating witness came to the Daytona Beach Police Department at 129 Valor Blvd. and gave a sworn statement that was audio

51 and video recorded.

52 The cooperating witness stated that the witness was present on Pearl Street at the time of the homicide on 12/31/15.

53 The cooperating witness stated that the witness has known Grip (Andre Mayo) for several years, and that the witness saw Grip firing a gun.

54 The cooperating witness stated that the witness saw Wayne Dawson (Anthony "Little Wayne" Dawson) shoot and kill Kevin Stanley.

55 The cooperating witness saw both Andre Mayo and Anthony Dawson firing their guns toward the group and the witness saw Anthony Dawson shoot

56 his gun at Kevin Stanley and then saw blood on Kevin Stanley's shirt.

57 The cooperating witness stated that Wayne Dawson was wearing a black hooded sweatshirt during the incident.

58 The cooperating witness repeated that the witness saw Grip shooting a gun, and that the witness does not know who killed the second victim.

59 The cooperating witness stated that it appeared that the first victim, Kevin Stanley, may have pulled out a handgun after Anthony Dawson began

60 shooting at him.

61 The cooperating witness has known Andre "Grip" Mayo for many years, and therefore Det. Loomis showed the witness a single photograph of Andre


62 Mayo. The witness positively identified the picture as being that of Andre Mayo.

63 The cooperating witness has known Anthony "Wayne" Dawson for several years, and therefore Det. Loomis showed the witness a single photograph

64 of Anthony "Wayne" Dawson. The witness positively identified the picture as being that of Anthony "Wayne" Dawson.

65 On 01/09/16, Detective Trisha Loomis and Detective David Dinardi interviewed Corey Brooks. Corey Brooks was present for the homicide on

66 12/31/15, and gave a sworn verbal statement.




67 Corey Brooks stated that he saw a black male pull out a gun, lean over, aim and shoot a gun at least five times.
 68 Corey Brooks stated that the shooter was wearing a black or gray "hoodie."
 69 Detective Dinardi showed Corey Brooks a photographic lineup that included a photograph of Anthony "Wayne" Dawson. Corey Brooks was not able
 70 to identify anyone in the lineup, but Corey Brooks did state that photograph #3 (Anthony Dawson) most resembled the shooter wearing the "hoodie."
 71 It should be noted that Anthony "Wayne" Dawson attempted to conceal his identify following the incident by not remaining on scene for the police to
 72 arrive in order to give his statement as to the sequence of events.

10 The video surveillance shows several people in the roadway in the 300 block of Pearl Street, standing outside of a vehicle. The vehicle was later											
11 identified as being a 2000 Chevrolet Impala, green in color, bearing a Florida tag of 8713TP, and belonging to the victim Abel Morel.											
12 The video then shows that a physical altercation takes place in the middle of the 300 block of Pearl Street. The video shows a male punch another											
13 male, and the male who was punched falls to the ground. The video then shows two males hitting and kicking the male on the ground. The male on											
14 the ground was later identified as Martell Smith.											
15 Video surveillance then shows someone start shooting towards the crowd.

34 Joseph Dudley stated that he did not get a good look at the shooter, but that he was wearing a black hooded sweatshirt.

35 Joseph Dudley stated that he did not know that Abel Morel had a gun, but that after the black male suspect began shooting at them Abel Morel pulled out a gun and fired towards the black male suspect, in defense of himself and his friends.

36

37 Det. Nathaniel Williams interviewed Tyler Montgomery at 129 Valor Blvd.

38 Tyler Montgomery stated that Kevin Stanley got into a fight with a black male, and that following the fight a crowd began to form around them.

39 Tyler Montgomery stated that he then heard gunshots, but he did not see the shooter.

40

41 Video surveillance shows that the black male suspect, with the black jacket, briefly enters a silver vehicle, which is parked in the 300 block of Pearl Street. The suspect then exits the vehicle and enters the Biarritz Club.

42 Video surveillance then shows the suspect exit the Biarritz Club, although the suspect is not wearing the black jacket when he exits the Biarritz Club, although he is still wearing a white t-shirt.

43

44 Video surveillance shows the suspect leaving the scene, walking north through Joe Harris Park.

45 I received a call from Anthony Brockington, who works at the Biarritz Club.

46 Anthony Brockington stated that after the shooting a black male, wearing a black jacket, entered the Biarritz Club, and asked if he could leave his jacket in the club. Anthony Brockington stated that he allowed the male to leave his jacket in the club, and the male then exited the club wearing a white t-shirt. Anthony Brockington stated that he knows the male who entered the club wearing a black jacket by the name nickname "Grip."

47

48 Anthony Brockington stated that he has known Grip for approximately 5 years.

49 Detective Sergeant Kelsey Harris received information that "Grip" is Andre Mayo, and that Andre Mayo is known to frequent the area of the Biarritz Club.

50

51 Detective Sergeant John Creamer and Detective Nathaniel Williams went to the Biarritz Club and showed Anthony Brockington a photograph of Andre Mayo, and Anthony Brockington stated that Andre Mayo is the person who he knows as Grip, and that he is the male who entered the Biarritz Club wearing a black jacket immediately after the shooting on 12/31/15.

52

53 Anthony Brockington, Tyler Montgomery, and Joseph Dudley gave sworn verbal statements that were audio and video recorded.

54 It should be noted that the suspect wearing a black jacket, Andre Mayo, attempted to conceal his identify following the incident by removing, and hiding, his jacket, and by not remaining on scene for the police to arrive in order to give his statement as to the sequence of events.

55

56 Andre Mayo is being charged in reference to this homicide based on the video surveillance showing that the shooter was wearing a black jacket and that the shooter then entered the Biarritz Club, and based on Anthony Brockington's sworn statement that Andre Mayo entered the Biarritz Club immediately after the shooting wearing a black jacket.
