NARRATIVE The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 06 day of December, 2016, at approximately 1124 a.m. p.m. at LPGA/WILLIAMSON DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 Defendant did willingly and unlawfully commit the act of pointing a laser light at V-01 (Mather) and commit the act of Aggravated Assault with the
 2 Laser which is a lighter that looks like a gun.
 3
 4 On 12/06/2016 at approximately 2324 hours Deputy Mather with the Volusia County Sheriff's Office advised via police radio that a silver 2014 Nissan
 5 bearing Florida tag ALUC64 was traveling southbound on Williamson Blvd from LPGA Blvd. Deputy Mather advised two occupants later identified as
 6 the defendant and co-defendant were pointing red lasers at passing vehicles to include Deputy Mather's vehicle which was an unmarked Volusia
 7 County Sheriff's Office pick up truck. Deputy Mather gave out the tag and followed the vehicle into the Carolina Club Apartments. Deputy Mather
 8 advised the vehicle pulled into the north side of the complex and the defendant and co-defendant exited the vehicle. As the defendant and
 9 co-defendant exited the vehicle Deputy Mather advised via radio that the defendant had a gun. Deputy Mather advised the defendant had a gun in
 10 his hand by his leg which caused Deputy Mather to be in fear for his life. At this point I pulled into the complex and observed Deputy Mather running
 11 to the rear of his vehicle for cover. I got my department issued M-16 and myself, Deputy Mather and Officer Quinones approached the vehicle. The
 12 defendant and co-defendant had already fled on foot prior to us approaching the vehicle. The vehicle was still occupied by (Briana Tananga), not
 13 knowing if she was armed like the defendant and co-defendant she was taken out of the vehicle at gun point. She was ordered back to Officers
 14 where she was escorted to the ground and detained.
 15 K-9 Officer Pearsall responded to the scene and utilized his K-9 partner who tracked the defendant and co-defendant to 108 Carolina Lake Dr #207.

 18 that it was only a lighter that looks like a gun with a laser attached to it. The laser the defendant had was located in the rear seat of the car where the
 19 defendant was sitting.
 20 When the defendant entered the apartment after fleeing on foot he took off his camo shirt/hat and put it on the kitchen counter and hid in the
 21 bathroom where he was located.
 22 The lighter was tagged into evidence. Axon video is available.
 23 V-01 completed a statement and wishes to prosecute.

 25 The defendant was read miranda and stated he understood. The defendant apologized and stated he did point the laser at vehicles. The defendant
 26 stated he knew that someone would think the laser could possibly be attached to a real gun.

 29 It should be noted the fake guns look like a small 22 caliber pistol/revolver.

 31 Deputy Mather was in fear for his life during this incident. Deputy Mather positively identified the defendant and co-defendant.


