

## THE CITY OF DAYTONA BEACH BOARD LIST

**AFFORDABLE HOUSING ADVISORY COMMITTEE** - Under Ordinance No. 93-37, Ordinance No. 96-259, Ordinance No. 08-112, Ordinance 19-39, and F.S. 420.9076 (2), states that the board shall consist of eleven members who are citizens recommended by the City Manager, the Mayor, or any City Commissioner and appointed by resolution of the City Commission for a two (2) year term. The Advisory Committee shall consist of at least 8 but not more than 11 committee members. The committee must consist of one representative from at least six of the following categories: (a) one **home builder** <sup>(HB)</sup>, (b) one **banking or mortgage representative** <sup>(BR)</sup>, (c) one **labor representative** <sup>(LR)</sup>, (d) one **low income advocate** <sup>(LI)</sup>, (e) one **for-profit affordable housing provider** <sup>(FPAHP)</sup>, (f) one **not-for-profit affordable housing provider** <sup>(NPAHP)</sup>, (g) one **real estate professional** <sup>(REP)</sup>; additionally (h) one member of the Planning Board <sup>(PB)</sup>, (i) one person who is a City resident <sup>(CR)</sup>, (j) one person who represents employers within the City<sup>(CE)</sup>, and (k) one person who represents essential services personnel<sup>(ES)</sup>.
