

Hearing of Cases

Case 1

CITATION NO. 0160159793 - Angela Collie is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - **Photo/Camera - Failure to Stop at Steady Red Signal**

Respondent was not present.

Ruling

Mr. Vukelja found the Respondent liable for the violation and imposed the fine of \$158 plus \$50 administration fee payable in 30 days.

Case 2

CITATION NO. 0160161982 - Antonia Conquest is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - **Photo/Camera - Failure to Stop at Steady Red Signal**

Mr. Antonia Conquest came forward and was sworn.

The video was reviewed.

Mr. Conquest stated he thought it was safer to go through the light at the time instead of slamming on his brakes.

Ruling

Mr. Vukelja found the Respondent liable for the violation and imposed the fine of \$158 plus \$50 administration fee payable in 30 days.
