Ms. Katie Grammel came forward and was sworn.

The video was reviewed.

Ms. Grammel stated the thought she could make it through the light but did not and conceded it was bad judgment.

Ms. Star Long came forward and was sworn.

The video was reviewed.

Ms. Long stated she is a good driver and she believed she was pushed to go through the red light. Ms. Long stated she did not have the funds to pay for the tickets.

Mr. Vukelja found the respondent liable and imposed the \$158 fine plus \$50 administrative fee subject to being paid within 30 days.

Ms. Long was present and previously sworn.

The video was reviewed.

#### Ruling

Mr. Vukelja found the respondent liable and imposed the \$158 fine plus \$50 administrative fee subject to being paid within 30 days.

#### Case 5

<u>CITATION NO. 0160164024 - Angela C. McGuinness</u> is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Respondent was not present.

# Ruling

Mr. Vukelja found the respondent liable and imposed the \$158 fine plus \$50 administrative fee subject to being paid within 30 days.

# Case 6

<u>CITATION NO. 0160164561 - Latisha M. Robinson</u> is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Ms. Latisha Robinson came forward and was sworn.

The video was reviewed.

Ms. Robinson stated the thought she was already over the stop bar when the light turned red.

Mr. Vukelja stated it was close but she was beyond the stop bar.

# Ruling

Mr. Vukelja found the respondent liable and imposed the \$158 fine plus \$50 administrative fee subject to being paid within 30 days

# Case 7

<u>CITATION NO. 0160165275 - Aaron A. Smith-Crawford</u> is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Mr. Aaron Crawford came forward and was sworn.

The video was reviewed.

Mr. Crawford stated the video does not show it but he was actually in the center lane and in order for him to avoid getting into an accident he had to go around that person and ended up running the red light and it was raining and he could not stop in time.

#### Ruling

Mr. Vukelja found the respondent liable and imposed the \$158 fine plus \$50 administrative fee subject to being paid within 30 days.

# Case 8

<u>CITATION NO. 0160163702 - Carrie J. Taylor</u> is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Ms. Carrie J. Taylor came forward and was sworn.

The video was reviewed.

Ms. Taylor stated the vehicle was her daughter's car and she was the co-signer.

Mr. Vukelja inquired if Ms. Taylor completed and affidavit of transfer to her daughter.

Ms. Taylor stated she thought she could come to the meeting to take care of the transfer.

Ms. Taylor completed the affidavit and submitted it to staff.

# Ruling

Mr. Vukelja found the Respondent not liable.

#### Case 9

<u>CITATION NO. 0160162583 - Kimberly A. Taylor</u> is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Ms. Kimberly Taylor came forward and was sworn.

The video was reviewed.

Ms. Taylor stated she was not driving that day and she submitted an affidavit but was not aware she was legally responsible for providing who the driver was.

Mr. Vukelja stated it was either going to her or someone who she provides the information for in the affidavit.

# Ruling

Mr. Vukelja found the Respondent not liable.

#### Case 10

<u>CITATION NO. 0160164416 - Richard D. Walker</u> is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Mr. Richard D. Walker came forward and was sworn. Mr. Walker stated he owns the car but does not drive it and unless there is a picture of who was driving he does not know who was driving.

#### Ruling

Mr. Vukelja found the respondent liable and imposed the \$158 fine plus \$50 administrative fee subject to being paid within 30 days.

#### Case 11

<u>CITATION NO. 0160163378 - Timothy J. Ziegler</u> is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Mr. Timothy Ziegler came forward and was sworn.

The video was reviewed.

Mr. Ziegler stated he did not have enough time to react to stopping at the yellow light. Mr. Ziegler stated he was driving a 3 ton vehicle and he would have ended up in the middle of the intersection if he would have stopped.

Mr. Jackson stated the yellow light time was adequate for the Respondent to stop.

# Ruling

Mr. Vukelja found the respondent liable and imposed the \$158 fine plus \$50 administrative fee subject to being paid within 30 days.

# Case 12

<u>CITATION NO. 0160163316 – Nebe C. Akosa</u> is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Mr. Nebe Akosa came forward and was sworn.

Mr. Akosa stated it was not necessary to review the video but he was requesting an extension to be able to pay the amount of the ticket. Ms. Akosa stated he would like to make payments.

# Ruling

Mr. Vukelja found the respondent liable and imposed the \$158 fine plus \$50 administrative fee subject to being paid within 60 days.

#### Case 13

<u>CITATION NO. 0160165352 – Sheila D. Murphy</u> is cited for Section 316.074(1) or Section 316.075(1)(c), Florida Statutes, - Photo/Camera - Failure to Stop at Steady Red Signal

Ms. Sheila Murphy came forward and was sworn.

Mr. Vukelja found the respondent liable and imposed the \$158 fine plus \$50 administrative fee subject to being paid within 30 days.
