

RESOLUTION NO. 19-90

A RESOLUTION AUTHORIZING SUBMITTAL OF AN APPLICATION TO AND ACCEPTANCE OF FUNDS FROM THE US DEPARTMENT OF HOMELAND SECURITY IN THE AMOUNT OF \$33,219 UNDER THE ASSISTANCE TO URBAN AREA SECURITY INITIATIVE (UASI) GRANT PROGRAM; AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO EXECUTE ALL NECESSARY DOCUMENTS IN FURTHERANCE OF THE GRANT APPLICATION AND ACCEPTANCE; AUTHORIZING AMENDMENT OF THE BUDGET AND EXPENDITURE OF THE GRANT FUNDS IF GRANT FUNDS ARE AWARDED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the US Department of Homeland Security, has grant funds available under the Urban Area Security Initiative (UASI) Grant program; and

WHEREAS, no matching funds are required for the grant; and

WHEREAS, the Police Department desires to acquire a DJI Wind 4 Drone and supporting equipment to be used in terrorism interdiction operations; and

WHEREAS, the Police Department recommends that the City submit its application for a grant in the amount of \$33,219 and accept the funds, if awarded; and

WHEREAS, the program requires a match from the City, and the Chief Financial Officer has submitted a Sufficiency of Funds Certificate for the required match in the amount of \$33,219.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:


SECTION 1. The City Commission hereby authorizes submission of a grant application to and acceptance of funds from the US Department of Homeland Security in the amount of \$33,219 from the Urban Area Security Initiative (UASI) Grant program for the purchase of a DJI Wind 4 Drone and supporting equipment to be used in terrorism interdiction operations.

A copy of the grant application in substantially final form is attached hereto and made a part hereof by reference.


SECTION 2. The City Manager or his designee is hereby authorized to execute all necessary documents in furtherance of the grant application and acceptance.

SECTION 3. The Budget Officer is hereby directed to amend the applicable Fiscal Year Revenue and Expense Budget in accordance with the grant funds authorized by this resolution; to carry forward unexpended budgeted grant funded expenditures, budgeted matching funds, and budgeted unearned grant revenues from fiscal year to fiscal year throughout the term of the grant; to adjust the budgeted grant funded expenditures and unearned revenues for program revenues, minor changes in the grant agreement, and accounting adjustments; to reduce budgeted matching funds based upon amendments to the grant agreement; and to close out unexpended budgeted grant expenditures and unearned budgeted grant revenues upon the expiration of the grant.

SECTION 4. This Resolution shall take effect immediately upon its adoption.
