

RESOLUTION NO. 2020-262

A RESOLUTION AUTHORIZING SUBMITTAL OF A GRANT APPLICATION TO AND ACCEPTANCE OF GRANT FUNDS FROM THE U.S. DEPARTMENT OF JUSTICE, BUREAU OF JUSTICE ASSISTANCE, 2020 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM, IN THE AMOUNT OF \$53,018 TO FUND THE DEPARTMENT'S INCREASED CRIME REDUCTION AND COMMUNITY ENGAGEMENT PROGRAM; AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO EXECUTE ALL NECESSARY DOCUMENTS IN FURTHERANCE OF THE GRANT APPLICATION AND ACCEPTANCE; AUTHORIZING AMENDMENT OF THE APPLICABLE FISCAL YEAR REVENUE AND EXPENSE BUDGET AND EXPENDITURE OF ALL FUNDS AWARDED; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the U.S. Department of Justice has grant funds available through the Edward Byrne Memorial Justice Assistance Grant ("JAG") Program for local criminal justice programs; and

WHEREAS, the City is seeking funding to fund the Department's increased crime reduction and community engagement program utilizing an ice cream truck wrapped in appropriate police department design; and

WHEREAS, the Police Chief recommends the City submit an application for grant funds in the amount of \$53,018 from the JAG Program, and that the grant funds be accepted if awarded.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DAYTONA BEACH, FLORIDA:

SECTION 1. The City Commission hereby authorizes submittal of an application to the U.S. Department of Justice, Bureau of Justice Assistance, 2020 Edward Byrne Memorial Justice Assistance Grant Program, for grant funds in the amount of \$53,018 to fund the Department's increased crime reduction and community engagement program utilizing an ice

cream truck wrapped in an appropriate police department design, and acceptance of the grant funds if awarded. A copy of the grant application in substantially final form is attached hereto and made a part hereof by reference.

SECTION 2. The City Manager or his designee is hereby authorized to execute all necessary documents in furtherance of the grant application and acceptance.

SECTION 3. The Budget Officer is hereby directed to amend the applicable Fiscal Year Revenue and Expense Budget in accordance with the grant funds authorized by this resolution; to carry forward unexpended budgeted grant funded expenditures, budgeted matching funds, and budgeted unearned grant revenues from fiscal year to fiscal year throughout the term of the grant; to adjust the budgeted grant funded expenditures and unearned revenues for program revenues, minor changes in the grant agreement, and accounting adjustments; to reduce budgeted matching funds based upon amendments to the grant agreement; and to close out unexpended budgeted grant expenditures and unearned budgeted grant revenues upon the expiration of the grant.


SECTION 4. This Resolution shall take effect immediately upon its adoption.
