

**EXECUTIVE ORDER NO. 2 OF THE MAYOR OF THE CITY OF DAYTONA BEACH
IN RESPONSE TO THE DECLARED LOCAL STATE OF EMERGENCY DUE TO
COVID-19**

WHEREAS, Governor Ron DeSantis, the governor of the state of Florida, issued on March 1, 2020, Executive Order 20-51 authorizing and directing the State Health Officer and Surgeon General to declare a public health emergency in the state of Florida as a result of the COVID-19 outbreak; and

WHEREAS, COVID-19 continues to be a threat to the public health of an unknown duration; and

WHEREAS, the City's Comprehensive Emergency Management Plan, adopted pursuant to Ch. 252, Florida Statutes, and City Resolution No. 19-131, provides that the Mayor may declare a local state of emergency for increments of seven days subject to City Commission approval and endorsement; and

WHEREAS, due to the COVID-19 pandemic, the Mayor previously issued a Declaration of a Local State of Emergency, executed on March 13, 2020, and an Amended Declaration of a Local State of Emergency and Executive Order, executed on March 17, 2020, for a seven day period; and

WHEREAS, the City Commission by Resolution No. 2020-69, affirmed, endorsed, and extended the Local State of Emergency due to COVID-19, for a seven day period ending at midnight on March 25, 2020; and

WHEREAS, the City Commission by Resolution No. 2020-70, further extended the Local State of Emergency for an additional seven day period ending at midnight, April 1, 2020, and adopted additional emergency measures to prevent the spread of the disease and to protect the health, safety, and welfare of the City's citizens; and

WHEREAS, Resolution No. 2020-70, provides that during this extension, emergency measures may be exercised as necessary as set forth in Section 2-3, City Code, and the Mayor shall have authority to execute executive orders as necessary to aid in their appropriate implementation; and


WHEREAS, I, as the Mayor of The City of Daytona Beach, have determined that additional emergency measures must be taken to protect the health and safety of the population.


NOW, THEREFORE, BE IT PROCLAIMED BY THE MAYOR OF THE CITY OF DAYTONA BEACH:

SECTION 1. All community pools, bingo halls, card rooms, community meeting facilities (excluding, however, houses of worship implementing social distancing as recommended by the CDC), and all group sporting, practice, and exercise venues involving close physical contact or sharing of equipment among participants, regardless of whether such facilities are on public or private property, are hereby ordered to be closed from public access.

SECTION 2. This Executive Order shall take effect immediately upon its issuance.
